## **Invitation to Bid for COMPLETION OF HEMODIALYSIS BUILDING GROUND FLOOR**

1. The *[FNLGHTC]*, through the *[INCOME-2020]*<sup>1</sup> intends to apply the sum of *TWO MILLION FIVE HUNDRED THOUSAND PESOS (Php2,500,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *[COMPLETION OF HEMODIALYSIS BUILDING GROUND FLOOR]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *[FNLGHTC]* now invites bids *[COMPLETION OF HEMODIALYSIS BUILDING GROUND FLOOR]*.<sup>2</sup> Completion of the Works is required **300 DAYS**. Bidders should have completed, within FIVE (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *[FNLGHTC]* and inspect the Bidding Documents at the address given below from *[8:00AM-5:00PM]*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *FIVE THOUSAND PESOS [P5,000.00]*.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *[FNLGHTC]* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
