## **Invitation to Bid for the COMPLETION OF HEMODIALYSIS BUILDING GROUND FLOOR**

1. The *[Far North Luzon General Hospital and Training Center]*, through the *[INCOME - 2020]* intends to apply the sum of *[Two Million Five Hundred Thousand Pesos (₱2,500,000.00)]* being the Approved Budget for the Contract (ABC) to payments under the contract for *[COMPLETION OF HEMODIALYSIS BUILDING GROUND FLOOR / 2020-43]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

***Select this for lot-procurement:***

The *[Far North Luzon General Hospital and Training Center]*, through the *[[INCOME - 2020]* intends to apply the sum of *[Two Million Five Hundred Thousand Pesos (₱2,500,000.00)/ Completion of Hemodialysis Building Ground Floor / 2020-43 / 1 lot]* being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *[Far North Luzon General Hospital and Training Center]* now invites bids for the above Procurement Project. Completion of the Works is required *[Ninety (90) Days]*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *[Far North Luzon General Hospital and Training Center]* and inspect the Bidding Documents at the address given below from *[Monday to Friday, 8AM-5PM]*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *[November 20, 2020]* from given address and website below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Five Thousand Pesos (₱5,000.00)]*. The Procuring Entity shall

allow the bidder to present its proof of payment for the fees *[Official Receipt or Deposit Slip]*

6. The *Far North Luzon General Hospital and Training Center* will hold a Pre-Bid Conference<sup>1</sup> on *November 27, 2020, 10am* at *DAD's Hall, FNLGHTC, Quirino, Luna, Apayao* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *[December 10, 2020, 10AM]*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on *[December 10, 2020, 10AM]* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *[Far North Luzon General Hospital and Training Center]* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
