**Invitation to Bid for CONSTRUCTION OF COVERED
WALK TO MORTUARY**

1. The *[FNLGHTC]*, through the *[INCOME-2020]*² intends to apply the sum of *ONE MILLION FOUR HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED FOURTEEN PESOS AND SIX CENTAVOS (Php1,465,514.06)* being the Approved Budget for the Contract (ABC) to payments under the contract for *[CONSTRUCTION OF COVERED WALK TO MORTUARY]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *[FNLGHTC]* now invites bids *[CONSTRUCTION OF COVERED WALK TO MORTUARY]*.³ Completion of the Works is required **30 DAYS**. Bidders should have completed, within FIVE (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *[FNLGHTC]* and inspect the Bidding Documents at the address given below from *[8:00AM-5:00PM]*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *FIVE THOUSAND PESOS [P5,000.00]*.
6. **Select one of the following two paragraphs, and delete the other:**⁴

The *[FNLGHTC]* will hold a Pre-Bid Conference on *[April 21, 2020, 1:00PM]* at

[FNLGHTC-DAD'S HALL, QUIRINO, LUNA, APAYAO], which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before *[May 19, 2020, 1:00PM]* at *FNLGHTC-DAD'S HALL, QUIRINO, LUNA, APAYAO*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The *[FNLGHTC]* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
