Invitation to Bid for *CONSTRUCTION OF HEMS/OPCEN AND TRIAGE 1 AREA*

1. The Far North Luzon General Hospital And Training Center], through the [funding year 2021 intends to apply the sum of PhP2,500,000.00 / CONSTRUCTION OF HEMS/OPCEN AND TRIAGE 1 AREA (2021-10-I) being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Far North Luzon General Hospital and Training Center now invites bids for the above Procurement Project. Completion of the Works is required August 1, 2021. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from m Far North Luzon General Hospital and Training Center and inspect the Bidding Documents at the address given below from Mon– Fri, 8AM – 5PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on February 8, 2021 from given address and website/s below PhP5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in persons.
6. The Far North Luzon General Hospital and Training Center will hold a Pre-Bid Conference¹ on February 16, 2021 11:00 AM at DAD’s Hall, FNLGHTC, Quirino, Luna, Apayao which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before March 1, 2021 11:00AM. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

9. Bid opening shall be on March 1, 2021 11:00AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Far North Luzon General Hospital And Training Center reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
