INVITATION TO BID FOR
SUPPLY AND DELIVERY OF HEMODIALYSIS SUPPLIES

1. The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER*, through the *INCOME 2020* intends to apply the sum of *ONE MILLION NINE HUNDRED THIRTY THREE THOUSAND FIVE HUNDRED PESOS (P1,933,500.00)* being the ABC to payments under the contract for *SUPPLY AND DELIVERY OF HEMODIALYSIS SUPPLIES*. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *FNLGHTC* now invites bids for the above Procurement Project. Delivery of the Goods is required by *[30 DAYS]*. Bidders should have completed, within *[2 years]* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *[Far North Luzon General Hospital & Training Center, Procurement Office, Administrative Building]* and inspect the Bidding Documents at the address given below during *[Monday – Friday, 8:00AM – 5:00PM]*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *[January 6, 2021-January 26, 2021]* from the given address and website(s) below *[upon payment of Five Thousand Pesos (P5,000.00)]*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *[in person,, or through electronic means.]*
6. The *[Far North Luzon General Hospital & Training Center]* will hold a Pre-Bid Conference¹ on *[January 13, 2021, 10:00 AM]* at *[DAD's Hall, FNLGHTC, Quirino, Luna, Apayao]*, which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *[January 26, 2021, 10:00 AM]*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *[January 26, 2021, 10:00 AM]* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *[Far North Luzon General Hospital and Training Center]* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
