



### **INVITATION TO BID**

#### **SUPPLY & DELIVERY OF DRUGS AND MEDICINES**

The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER* through the *[TRUST FUND 2018]*<sup>1</sup> intends to apply the sum of *[NINE MILLION SIX HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED SEVENTY TWO PESOS AND SEVENTY TWO CENTAVOS]* P 9,622,472.72 being the Approved Budget for the Contract (ABC) to payments under the contract for *[SUPPLY & DELIVERY OF DRUGS AND MEDICINES]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- (i) The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER* now invites bids for ***SUPPLY & DELIVERY OF DRUGS AND MEDICINES***
- (ii) <sup>2</sup> Completion of the Works is required *[30 DAYS]*. Bidders should have completed, within TWO (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- (iii) Interested bidders may obtain further information from *[FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER]* and inspect the Bidding Documents at the address given below from *[8AM-5PM]*.
- (iv) A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *[10,000.00]*.
- (v) The *[FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER]* will hold a Pre-Bid Conference on *[August 2, 2018, 10AM]* at *[dad’s hall, fnlghtc, luna, apayao]*, which shall be open to all interested parties.
- (vi) Bids must be delivered to the address below on or before *[August 17, 2018, 10AM]* at *[DAD’S HALL, FNLGHTC, QUIRINO, LUNA, APAYAO]*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB .
