

INVITATION TO BID

SUPPLY & DELIVERY OF HEMATOLOGY SUPPLIES & REAGENTS

The FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER through the [TRUST FUND 2018]¹ intends to apply the sum of [TWO MILLION FIVE HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED FORTY PESOS (2,584,340.00) being the Approved Budget for the Contract (ABC) to payments under the contract for [SUPPLY & DELIVERY OF HEMATOLOGY SUPPLIES & REAGENTS). Bids received in excess of the ABC shall be automatically rejected at bid opening.

- (i) The FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER] now invites bids for SUPPLY & DELIVERY OF HEMATOLOGY SUPPLIES & REAGENTS
- (ii) ² Completion of the Works is required [30 DAYS]. Bidders should have completed, within TWO (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- (iii) Interested bidders may obtain further information from [FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER] and inspect the Bidding Documents at the address given below from [8AM-5PM].
- (iv) A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of [5,000.00].
- (v) The [FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER] will hold a Pre-Bid Conference on [August 14, 2018, 1PM] at [dad's hall, fnlghtc, luna, apayao], which shall be open to all interested parties.
