



INVITATION TO BID FOR

SUPPLY, DELIVERY AND INSTALLATION OF 250 KVA TRANSFORMER

1. The [FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER], through the [INCOME-2018]¹ intends to apply the sum of [ONE MILLION FIVE HUNDRED THOUSAND PESOS) being the Approved Budget for the Contract (ABC) to payments under the contract for [SUPPLY, DELIVERY AND INSTALLATION OF 250 KVA TRANSFORMER]. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The [FNLGHTC] now invites bids for *the supply, delivery and installation of 3 units 250 KVA transformer, brand new*.² Delivery of the Goods is required *15 days after NTP*. Bidders should have completed, within [two years] from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from [fnlghtc] and inspect the Bidding Documents at the address given below during [8AM-5PM].
5. A complete set of Bidding Documents may be acquired by interested Bidders on [June 13, 2018] from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS* .
6. The [FNLGHTC] will hold a Pre-Bid Conference³ on [June 13, 2018, 9AM] at [CMPS OFFICE, FNLGHTC, QUIRINO, LUNA, APAYAO], which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before [June 26, 2018, 9am]. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

² A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.
