

## ***Far North Luzon General Hospital & Trng. Ctr]***

### **INVITATION TO BID FOR *[Supply & Delivery of Laboratory Supplies***

1. The *[FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER]*, through the *[GAA-2012]*<sup>1</sup> intends to apply the sum of *Three Million Four hundred thirty two thousand seven hundred ninety eight pesos]* being the Approved Budget for the Contract (ABC) to payments under the contract for *[Supply & Delivery of Laboratory Supplies]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER*, now invites bids for *[Supply & Delivery of Laboratory Supplies ]*.<sup>2</sup> Delivery of the Goods is required *thirty (15) days after NOA*. Bidders should have completed, within *[two years]* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

4. Interested bidders may obtain further information from *[FNLGHTC]* and inspect the Bidding Documents at the address given below during *[8:00AM-12:00, 1:00-5:00 PM]*.

5. *Select one of the following two paragraphs, and delete the other:*<sup>3</sup>
