INVITATION TO BID FOR *[Supply & Delivery of MEDICAL SUPPLIES*

1. The *[FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER]*, through the *[GAA-2012]*¹ intends to apply the sum of *Five Million Eight hundred Ninety Three Thousand One Hundred Ten Pesos (P5,893,110.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *[Supply & Delivery MEDICAL SUPPLIES]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER*, now invites bids for *[Supply & Delivery of MEDICAL SUPPLIES]*.² Delivery of the Goods is required *thirty (15) days after NOA*. Bidders should have completed, within *[two years]* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

In addition, select one of the two following paragraphs and delete the other depending on the existence of conditions under Section 23.5.1.2 of the IRR of RA 9184:

- (i) Select this paragraph if condition (a), (c), or (d) under Section 23.5.1.2 of the IRR of RA 9184 exists:*** Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from *[FNLGHTC]* and inspect the Bidding Documents at the address given below during *[8:00AM-12:00, 1:00-5:00 PM]*.

A complete set of Bidding Documents may be purchased by interested Bidders on *[August 17, 2015]* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *[FIVE thousand pesos]*.

5. *Select one of the following two paragraphs, and delete the other:*³

The [FNLGH&TC] will hold a Pre-Bid Conference on [August 17, 2015, 11AM at [FNLGHTC Conference Room, Quirino, Luna, Apayao], which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before [August 31, 2015, 11AM]. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on [August 31, 2015] at [FNLGHTC Conference Room, Quirino, Luna, Apayao]. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The [FNLGHTC] reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
