

## ***Far North Luzon General Hospital & Trng. Ctr]***

### **INVITATION TO BID FOR *Supply & Delivery of IV FLUIDS AND ADDITIVE SOLUTIONS***

1. The [*FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER*], through the [*GAA-2012*]<sup>1</sup> intends to apply the sum of *One Million Five hundred thousand Pesos (P 2,710,996.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for [*Supply & Delivery of IV FLUIDS AND ADDITIVE SOLUTIONS*]. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *FAR NORTH LUZON GENERAL HOSPITAL & TRAINING CENTER*, now invites bids for [*Supply & Delivery of IV FLUIDS AND ADDITIVE SOLUTIONS*].<sup>2</sup> Delivery of the Goods is required *fifteen (15) days after NOA*. Bidders should have completed, within [*two years*] from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

6. Bids must be delivered to the address below on or before *[May 17, 2016, 1PM]*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on *[May 17, 2016, 2015, 1PM]* at [FNLGHTC Conference Room, Quirino, Luna, Apayao]. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The [FNLGHTC] reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
