- The *Far North Luzon General Hospital and Training Center* now invites bids for the above Procurement Project. Delivery of the Goods is required by **30 Calendar days upon receipt of Purchase Order (Multiple PO)**. Bidders should have completed, within **Two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from *Far North Luzon General Hospital & Training Center, Procurement Office- Administrative Building* and inspect the Bidding Documents at the address given below during **Monday – Friday 8:00AM – 5:00PM**.
