



INVITATION TO BID FOR SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND TESTING OF MEDICAL EQUIPMENT FOR ANESTHESIA DEPARTMENT

1. The Far North Luzon General Hospital and Training Center, through the Internally Generated Income intends to apply the sum of Two million Six Hundred Pesos (Php2,600,000.00) being the ABC to payments under the contract for Supply, delivery, Installation, Commissioning and Testing of Medical Equipment for Anesthesia Department / IB No. 2024-02-018-G. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Far North Luzon General Hospital and Training Center* now invites bids for the above Procurement Project. Delivery of the Goods is required within *Sixty (60) Calendar Days.* Bidders should have completed, within *Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5. The Prospective Bidder can officially join the bidding procedure by making a payment in conformance to Section 5.0 of APPENDIX 8 regarding the **Guidelines on the Sale of Bidding Documents**:

- 6. Payment of the applicable fee for the Bidding Documents must be made before opening of bids. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person by facsimile, or through electronic means.
- 7. The *FNLGHTC* will hold a Pre-Bid Conference¹ on *February 13, 2024, 9:00 am* at *FNLGHTC, DAD's Hall Administrative Building* which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below, on or before *February 26, 2024, 9:00 am*. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 10. Bid opening shall be on *February 26, 2024, 9:00 am*. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The *Far North Luzon General Hospital and Training Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
