The Far North Luzon General Hospital and Training Center, through the National Expenditure Program 2025 intends to apply the sum of Two Million Two Hundred Seventy-Five Thousand Pesos (Php2,275,000.00) being the ABC to payments under the contract for Supply and Delivery of Medical Oxygen Refill / IB No. 2025-01-005-G-EPA. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **FNLGHTC** now invites bids for the above Procurement Project. Delivery of the Goods is required by 180 calendar days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on September 25-October 8, 2024 from the given address below and payment website(https://fnlghtc.doh.gov.ph/invitation-to-bid/), of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00) must be made before opening of bids. The Procuring Entity shall allow the bidder to









present its proof of payment for the fees in person, by facsimile, or through electronic means.

- 6. The FNLGHTC will hold a Pre-Bid Conference¹ on September 25, 2024, 2:00 pm at FNLGHTC, DAD's Hall - Administrative Building which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before October 8, 2024, 2:00 pm. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on October 8, 2024, 2:00 pm. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The **FNLGHTC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
