



## INVITATION TO BID FOR *PROCUREMENT OF SEMI- EXPENDABLE MEDICAL EQUIPMENT*

1. The *Far North Luzon General Hospital and Training Center*, through the *Internally Generated Fund* intends to apply the sum of *Five Hundred Fifty-Four Thousand Pesos (Php554,000.00)* being the ABC to payments under the contract for *Procurement of Semi-Expendable Medical Equipment / IB No. 2024-10-074-G*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Far North Luzon General Hospital and Training Center* now invites bids for the above Procurement Project. Delivery of the Goods is required within **Thirty (30) Calendar Days**. Bidders should have completed, within **Two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

amount of **One Thousand Pesos (Php1,000.00)** must be made before opening of bids. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

6. Payment of the applicable fee for the Bidding Documents must be made before opening of bids. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person by facsimile, or through electronic means.
7. The **FNLGHTC** will hold a Pre-Bid Conference<sup>1</sup> on **October 16, 2024, 10:00 am** at **FNLGHTC, DAD's Hall – Administrative Building** which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below, on or before **October 28, 2024, 10:00 am**. Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be on **October 28, 2024, 10:00 am** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
11. The **Far North Luzon General Hospital and Training Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
